**WE HELP FARMERS AND FARMLAND OWNERS ACCESS, CARE FOR AND PASS ON WORKING FARMLAND AND FARM BUSINESSES. IN 2017, WE PROVIDED OVER 390 NEW CASES OF DIRECT TECHNICAL ASSISTANCE TO FARMERS, LANDOWNERS, PROFESSIONALS AND COMMUNITIES. APPROXIMATELY 350 FARM SEEKERS AND 150 TRANSITIONING FARM FAMILIES WERE TRAINED THROUGH 26 EDUCATIONAL EVENTS. OUR EDUCATIONAL MATERIALS AND TOOLS WERE USED BY 5,000 REGISTERED RESOURCE USERS AND OUR WEBSITE HAD 118,000 NEW USERS.
